Victims Support Portal (academicintegrity.eu/victims)

A new interactive online Portal has recently been launched to support victims of misconduct in research and education. The Portal is part of the Erasmus+ FAITH project that aims to create a benchmark for minimum standards for academic integrity policies in Europe and beyond, based on good practices internationally (Project Result 1). The FAITH project also aims to help academics and undergraduate students to prevent, deter and detect academic misconduct through evidence-based guidance and training materials (Project Result 2). The development of an interactive online portal to support victims of misconduct in research and education is the final aim of the FAITH project (Project Results 3)

Information to potential victims of misconduct in research and education

Who are the potential victims of misconduct in research and education?

- Victims of plagiarism;
- Whistleblowers;
- People unfairly accused of an unethical action;
- Victims of abuse;
- Institutional “witch-hunting”;
- Etc.

How can potential victims get support from the Portal?

- Discuss cases of misconduct in research and education in confidence with a team of experts in academic integrity issues;
- Experts will provide advice to potential victims on the actions to take, according to the nature of their cases;
- Build a community of support for potential victims of misconduct in research and education to share their cases and others to offer support and guidance;
- Foster a culture of academic integrity in Europe and beyond.

Information to academics and researchers who would like to be involved and contribute as experts in the Victims Support Portal:

What do we expect from our experts?

- Academics and researchers with some level of experience in academic integrity issues (e.g. plagiarism, contract cheating, data manipulation, publication ethics, supervisory issues, etc.);
- Willingness to engage in a dialogue with potential victims to support them in the actions to take, according to their cases;
- Experience in mentoring (desired but not critical);
- Experience from an ethical advisory committee or from an integrity office (desired but not critical);
- Disseminate the Portal to their networks;
- Promote a culture of academic integrity in Europe and beyond.

A list of experts will be made public in the Portal (soon). This list will include the name, affiliation, brief description and expertise of our experts. Victims who seek support in a case of misconduct in research and education will be offered the option to choose the expert(s) they would like to receive support from.
