

ENAI Annual Report 2022

The European Network for Academic Integrity, association (ENAI), is registered in the Associations Register of the Czech Republic, identification number (IČO): 6273629, file number L23001, registered at the Regional Court in Brno (Krajský soud v Brně). ENAI was founded on 22nd May 2017. The mission of ENAI is to support higher education institutions to work together in the field of academic integrity. ENAI defines academic integrity as compliance with ethical and professional principles, standards and practices by individuals or institutions in education, research, and scholarship (ENAI Glossary for Academic Integrity, 2018).

The objectives of ENAI are to promote integrity in all parts of academia (i.e., education, research and other aspects of the academic sector), specifically:

- To foster a culture of academic integrity at the European level and beyond;
- to collaborate towards research and promotion of academic integrity;
- to provide a platform for academics and other stakeholders across all sectors to investigate, exchange, develop, collaborate and access resources in the field of academic integrity;
- to offer opportunities for students, researchers, educators and practitioners to take a leadership role in the field of academic integrity;
- to present best practices in the management of academic integrity;
- to provide dedicated educational resources and guidelines documents of reference, accessible to use by the wider academic community;
- to organise conferences, workshops and other events;
- to network and collaborate with individuals and organisations actively pursuing related research on different topics of academic integrity (e.g. plagiarism, contract cheating, authorship);
- via the ENAI Awards to recognise and distinguish the individual and institutional efforts and contributions in promoting academic integrity culture and practices.

Overview of ENAI Members (2017 – 2022)




Figure 1 – Overview of the ENAI Members (2017-2022)

Figure 1 provides an overview of the number of institutional members and individual supporters since the foundation of ENAI in 2017. In 2017, when ENAI was registered as a legal entity, ENAI had 13 institutional members (including eight founding members from the original Erasmus+ project: European Network for Academic Integrity) and six individual supporters. Academic Integrity Policies

Head: Salim Razı, Canakkale Onsekiz Mart University, Türkiye

Aims: The Academic Integrity Policies Working Group (<u>AIP WG</u>) aims to 1) support institutions to develop their academic integrity policies, 2) help institutions revise existing policies, and 3) provide the know-how to institutions in the establishment of integrity culture at an institutional level.

Members: There are currently 20 members of the AIP WG, including the head.

Activities: There were seven meetings with the working group members in 2022. Some of these meetings included presentations by the members on the academic integrity policies in their countries. Other meetings included discussions about conference presentations, discussions of any necessary modifications in the description shared in the working group webpage and other activities to implement during 2022.

Plans for 2023: Members of the working group are planning to have a presentation dealing with artificial intelligence in academic integrity policies at the next ENAI Annual Conference (European Conference on Ethics and Integrity in Education 2023, 12th-14th July 2023, Derby, UK). Members have set up a team to help Mendel University (Czechia) to revise its institutional academic integrity policy.



Academic Integrity Surveys

Head: Alireza Salehi Nejad, University of Tehran, Iran*

*Alireza Salehi Nejad replaced Inga Gaižauskaitė as the new head of the working group

Aims: The Academic Integrity Surveys Working Group (<u>AIS WG</u>) aims to 1) explore ways of allowing access to different tools and the resulting responses, 2) exchange experiences of researching academic integrity, looking into the advantages and disadvantages of using surveys and other methods of data collection as well as research designs, and 3) offer support in areas such as (but not limited to) research methodology, survey tool development, research ethics related questions as an advisory team for ENAI research projects.

Members: There are currently 11 members of the AIS WG, including the head.

Activities: Members of the working group held regular meetings throughout 2022. In these meetings, discussions were made about abstract submissions for conferences and the development of workshops. At the end of 2022, the leadership of the working group has changed and starting from January 2023, Alireza Salehi-Nejad has been approved by the ENAI Board as the new leader of the AIS WG.

Plans for 2023: Members of the AIS WG plan to promote and encourage studies testing the Academic Integrity Self-Evaluation Tools and implement any necessary revisions based on the results. Additionally, the AIS WG is planning to organise a workshop on how to conduct and deal with peer review, focusing on dealing with the ethical aspects and primary data as part of the ENAI Monthly Webinars. Members aim to propose one panel and one workshop for the European Conference on Ethics and Integrity in Academia 2023 (ECEIA 2023). Also, there is a plan to encourage members to collaborate in writing a commentary for World Ethics Day (October 2023). Working group members are encouraged to further collaborate on research projects, leading to the publication of short papers or research articles.

Addressing Contract Cheating

Head: Sonja Bjelobaba, Uppsala University, Sweden

Aims: The Addressing Contract Cheating Working Group (<u>ACC WG</u>) aims to **1)** research, discuss and educate about different aspects of contract cheating, such as prevention, detection and reaction; **2)** assimilate and assist with policy documents and pedagogical strategies that can decrease the risk of contract cheating in different countries and institutions.



Members: There are currently 20 members of the ACC WG, including the head.

Activities: Members of the ACC WG conducted regular meetings in 2022. These meetings are called "master classes", where each has a specific topic on addressing contract cheating and is moderated by one working group member. In 2022, there were four master classes:

- ✓ April 5th, 2022: "Contract Cheating in Sweden", leader: Sonja Bjelobaba (Uppsala University, Sweden)
- ✓ October 20th, 2022: "Contract Cheating Checklists", leaders: Olumide Popoola (Queen Mary University of London, United Kingdom) & Lorna Waddington (University of Leeds, United Kingdom)
- ✓ December 12th, 2022: "Contract Cheating in Ireland", leaders: Sue Hackett & Mairéad Boland (Quality and Qualifications Ireland, Ireland)

Presentations made at conferences: Several members discussed contract cheating at different conferences (including the ENAI Annual Conference 2022, European Conference on Academic Integrity and Plagiarism 2022, ECAIP 2022, $4^{th} - 6^{th}$ May 2022, Porto, Portugal). Also, Thomas Lancaster presented a webinar titled "Artificial intelligence and academic integrity" (9^{th} September 2022) as part of ENAI & CRB (Centre for Research Ethics & Bioethics, Uppsala University, Sweden) Monthly Webinars.

Plans for 2023: Members of the ACC WG plan to have more discussions on Artificial Intelligence as a form of contract cheating. As a group, members have decided not to focus on writing joint papers but on having master classes.

Educational Materials on Academic Integrity

Head: Ansgar Schäfer, HTWG Konstanz - University of Applied Sciences & University of Konstanz, Germany

Aims: The Educational Materials on Academic Integrity Working Group (<u>EMAI WG</u>) aims to **1)** manage and develop the ENAI Database of Educational Materials on Academic Integrity, and **2)** become a reference for anyone searching for educational resources on academic integrity.

Members: There are currently 8 members of the EMAI WG, including the head.

Activities: In 2022, working group members started reviewing the educational materials database to implement changes in the current online platform. Members see this as urgent to facilitate users' search



for materials and make the database a reference for educational materials on academic integrity. Members have discussed the currently available materials, data structure, database usage and usability.

Presentations made at conferences: Members of the working group have not presented at conferences during 2022. However, the <u>ENAI Educational database</u> and the activities of the working group were presented at the following workshops and events:

- Two workshops for library staff at the Library Academy, Munich (Germany), in January & December 2022, and with approximately 30 participants
- PhD workshop (online) for Universities in Baden-Württemberg (Germany) in October 2022, with approximately 25 participants
- PhD workshop (hybrid) for Romanian Universities (Romania), in November 2022, with approximately 90 participants
- Higher Education Institution Teachers workshop at the University of Suceava (Romania) in November 2022, with approximately 40 participants

ENAI Awards

Head: Teddi Fishman, United States of America

Aims: The ENAI Awards Working Group (<u>EA WG</u>) aims to **1)** award individuals for significant, innovative or ground-breaking advancements towards academic integrity core values, goals and/or culture change in practice.

Members: There are currently 3 members of the EA WG, including the head.

Activities: In 2022, the EA WG kept its focus on recognising, inspiring and celebrating significant and innovative achievements in the field of academic integrity and bringing attention to the exceptional work made by individuals and institutions in this field. The main activities carried out by the members consisted of revising and sending out a call for the 2022 ENAI Awards, tweaking processes in order to streamline the nomination procedures, slightly updating the instructions for submissions, and selecting and presenting the ENAI awards during the 2022 ENAI Annual Conference (European Conference on Academic Integrity and Plagiarism, $4^{th} - 6^{th}$ May 2022, Porto, Portugal).

Presentations made at conferences: Members of the working group presented the 2022 ENAI Awards during the conference.



Plans for 2023: Late in 2022, members revised and sent out a call for the 2023 ENAI Awards. The selection procedure will start soon, and awardees will be announced during the 2023 ENAI Annual Conference (European Conference on Ethics and Integrity in Academia, $12^{th} - 14^{th}$ July, Derby, UK).

Ethics and Integrity Advisory Group

Head: Shivadas Sivasubramaniam, University of Derby, United Kingdom

Aims: The Ethics and Integrity Advisory Group (<u>EIAG</u>) aims to 1) render advice and assistance to develop institutional ethics committees and their regulations in member institutions, 2) share good practice in research and academic ethics, 3) act as a critical guide to institutional review processes assisting them in maintaining/achieving ethical standards, 4) collaborate with similar bodies in establishing collegiate partnerships to enhance awareness and practice in this field, 5) provide support within and outside ENAI to develop materials to enhance teaching activities in this field, 6) organise training for students and young researchers about ethical behaviours in the form of lectures, seminars, debates and webinars, and 7) enhance research and disseminate the findings in matters and topics related to ethics.

Members: There are currently 8 members of the EIA WG, including the head.

Activities: In 2022, working group members met a few times to discuss the development of the ENAI Ethical Approval procedures and to discuss the submission of an abstract for the European Conference on Academic Integrity and Plagiarism (ECAIP), $4^{th} - 6^{th}$ May 2022, Porto, Portugal.

Plans for 2023: Members plan to develop teaching materials for ethics education for school teachers during 2023. Furthermore, the group aims to establish workshop materials for ethics and ethical behaviour for secondary school students aimed at University entry-level students. Shiva, Zeenath and



Salim are submitting a paper for the European Conference on Ethics and Integrity in Academia 2023 (ECEIA 2023) on "The influence of ambiguous assessment briefs resulting in misinterpretations and academic misconduct".

Ethical Publishing and Dissemination

Head: Irene Glendinning, Coventry University, United Kingdom

Aims: The Ethical Publishing and Dissemination WG (EPAD WG) aims to 1) identify, define and characterise questionable editorial, publishing and dissemination practices, 2) promote institutional academic integrity, using existing checklists to identify disreputable publishers and conferences, 3) disseminate good practice – perhaps with reference to COPE (Committee on Publication Ethics), 4) highlight the threats from disreputable publishers and conferences, 5) provide support to students and scholars for developing knowledge and skills in distinguishing reputable from disreputable publications/journals/events, 6) conduct research about this phenomenon, for example – explore where/how/to what extent academic progression and promotion depend on the predatory industry, and 7) network/collaborate with institutions, working groups, other people interested in this topic.

Members: There are currently 20 members of the EPAD WG, including the head.

Activities: The members have various backgrounds, interests, expertise and priorities, which provides a rich source of information for learning from each other and sharing resources and knowledge, which are reflected in the variety of WG activities. Members of the working group met six times during 2022. These meetings were held to promote discussions among working group members on the activities and conference presentations the group would like to be involved in. The group submitted a workshop proposal for the European Conference on Academic Integrity and Plagiarism (ECAIP 2022), 4th - 6th May 2022, Porto, Portugal. The group also submitted proposals for the IRAFPA (Institute of Research and Action on Fraud and Plagiarism in Academia) Conference in Coimbra (Portugal) in June 2022. The group agreed to collaborate with IRAFPA to develop resources (videos) on peer review. Working group members worked on developing predatory publishing checklists and generic guidance notes for peer reviewers, authors and editors and shared interesting research and papers. There were also discussions regarding making contributions to the Erasmus+ FAITH project.

Plans for 2023: Presentations from Seyyed Miri (14th April 2023) and Emanuel Kulczycki (5th June 2023) about their research. Irene and Salim will deliver a pre-conference workshop on Ethical Publishing and Dissemination at the European Conference on Ethics and Integrity in Academia (ECEIA 2023), 12th – 14th June 2023, Derby, UK. A workshop will also be held during ECEIA 2023 to present the resources developed. Provide a summer school workshop in Maribor, August 2023; complete and maintain a checklist to help to identify disreputable publishers and fake conferences (work in progress); refine the guidance for peerreviewers and authors/editors and complete; publish a journal paper based on the webinar held in October 2021 (Putting our trust in academic publications – how can we know whether the research and results are reliable?). The group also aims to develop/publish a full paper from: Strengths and weaknesses of peer review: Enhancing integrity and professional standards in publications – extended abstract ECAIP 2022. Plans have also been made to reconnect with IRAFPA to develop the videos as planned, contribute to the Erasmus+ FAITH project with materials and workshops, and network with the scientific community through NERQ (Network for Education and Research Quality) and other organisations. Members also aim to investigate the possibility of applying for research funding after deciding on the research focus and exploring funding sources.

Gamification of Academic Integrity

Head: Zeenath Reza Khan, University of Wollongong Dubai, United Arab Emirates

Aims: The Gamification of Academic Integrity Working Group (<u>GAI WG</u>) aims to **1)** explore gamification and game-based learning to enhance engagement and commitment of academic stakeholders (students, staff, faculty, management, parents) towards teaching and learning of academic integrity values, and **2)** gamify certain areas of academic integrity in order to offer the greater community with the tools to use them in their teaching and learning settings.

Members: There are currently 11 members of the GAI WG, including the head.



Activities: The Gamification of Academic Integrity working group won a research grant from the University of Wollongong Global Enterprises to develop game-based learning modules on academic integrity with an extended team. The group received approximately AUD10,000, which allowed them to start developing the gamified modules. Members ran one round of focus groups and collected results. The design team completed the game and, in collaboration with the ENAI IT team, made it available on the ENAI webpage. However, since final tests are ongoing, the group decided not to make the game publicly available until it is finalised.

Plans for 2023: Members will complete and launch the game in 2023. Additionally, the group is planning to develop support materials for the game and present the findings from the project at the ENAI Annual Conference 2023 (European Conference on Ethics and Integrity in Academia 2023, 12th – 14th June 2023, Derby, UK). During a panel discussion about the Gamification of Academic Integrity, the group will also present the game in the ENAI & CRB Monthly <u>Webinars</u> in March 2023.

Glossary & Guidelines

Head: Július Kravjar, European Network for Academic Integrity, Slovakia

Aims: The Glossary and Guidelines Working Group (<u>GG WG</u>) aims to **1)** maintain and develop the ENAI Glossary for Academic Integrity and the General Guidelines for Academic Integrity.

Members: There are currently 7 members of the GG WG, including the head.

Activities: Members of the working group prepared a platform (<u>Google form</u>) to collect any requests for changes to the current definitions of the Glossary and Guidelines made by other working group leaders and extended ENAI network. There were three requests for changes to the current definitions: Academic Integrity, Contract Cheating and Plagiarism. These were processed and resolved.

Plans for 2023: Members of the working group aim to continue promoting their activities, consider any requests for change made to the Glossary and Guidelines, and develop infographics of selected complex



terms of the Glossary for Academic Integrity to make it easily understood by the academic community. If proven useful, members will develop infographics for the Guidelines too. There are plans to have the Glossary translated into Farsi language. The group will discuss the potential consequences of using machine text generators in the Glossary and Guidelines.

Integrity in School Education

Head: Özgür Çelik, Balikesir University, Türkiye

Aims: The Integrity in School Education Working Group (<u>ISE WG</u>) aims to 1) promote academic integrity across school education (i.e. from primary school to secondary school), 2) contribute to the scientific knowledge (e.g. papers, conferences, workshops), 3) design and develop teaching materials about academic integrity tailored to primary and secondary school levels, 4) collaborate with primary and secondary schools to develop and implement academic integrity policies, 5) develop workshops about academic integrity for primary and secondary school teachers, and 6) develop initiatives for teachers and students to dialogue about academic integrity.

Members: There are currently 14 members of the ISE WG, including the head.

Activities: Since its establishment in 2021, the ISE WG has been growing with the participation of new members from different countries and disciplines. Members span from academics to librarians and school teachers. The group met three times during 2022. The first meeting was an introductory meeting, where members introduced themselves and talked about future activities they wished to see implemented in the working group. In the second meeting, members finalised the working group description, changed the initial name (i.e. Integrity in Secondary Education) and discussed potential research ideas. In the third meeting, members decided to attend the ENAI Annual Conference 2023 (European Conference on Ethics and Integrity in Academia 2023; 12th – 14th July 2023; Derby, UK) as a group to present a scoping review study on academic integrity at K-12 level. The group will work on such a study and submit an abstract for the conference in early 2023.

Plans for 2023: Members are planning to attend the European Conference on Ethics and Integrity in Academia 2023 with a presentation. Furthermore, discussions have been made to propose a research project to support K-12 teachers in academic integrity. The group is looking for suitable project calls.

Outreach

Head: Zeenath Reza Khan, University of Wollongong in Dubai, United Arab Emirates



Aims: The <u>Outreach Working Group</u> aims to **1)** work with like-minded members to develop strategies to provide accessibility of resources, training, advice and expertise to institutions, individuals and students to help establish a culture of integrity beyond borders.

Members: There are currently 10 members of the Outreach WG, including the head.

Activities: During 2022, the group was active in applying for a grant to work on a research project to map key (K) academic integrity (AI) values to the United Nations' (UN) Sustainable Development Goals (SDG). The group created an extended team through the University of Wollongong Global Enterprises and applied for a grant. The group obtained funds (AUD 6,995/-) to develop the project (AIKUNSDG). The project team met several times during 2022 and began working on the mapping process. Besides the work conducted for the AIKUNSDG project, the working group helped organise the ENAI PhD Summer School, held face-to-face in Canakkale Onsekiz Mart University, Türkiye.

Head: Oraz Myradov*, European Students' Union

Aims: The <u>Students' Working Group</u> aims to: **1)** integrate students and student bodies in ENAI activities, **2)** support the student community with academic integrity tools and resources, **3)** consult with ENAI members on students' involvement in the area of academic integrity, **4)** conduct research on academic integrity involving student bodies of ENAI members, and **5)** publish Academic Integrity Student Chapters.

Members: There are currently 3 members of the Students' Working Group, including the head.

Activities: The group prepared guidelines for <u>Academic Integrity Chapters</u> for students in 2022. Oraz Myradov and Megan O'Connor gave a webinar titled "Celebrating the European Year of Youth through Academic Integrity. How students help in establishing institutional integrity and values" as part of ENAI & CRB (Centre for Research Ethics & Bioethics, Uppsala University, Sweden) Monthly <u>Webinars</u>.

Support for the Victims of Academic Misconduct

Head: Rita Figueiras Alves dos Santos, European Network for Academic Integrity, Portugal



Aims: The Support for the Victims of Academic Misconduct Working Group (<u>SVAM WG</u>) aims to **1**) raise awareness of misconduct and questionable practices in research and education and **2**) provide a safe place for anyone who seeks advice on an issue of misconduct or questionable practice in research or education.

Members: There are currently 10 members of the SVAM WG, including the head.

Activities: Members of the working group agreed to improve the <u>Victim Support Portal</u> until the end of the Erasmus+ <u>FAITH</u> project. The group met two times in 2022 to discuss technical aspects of the Victim Support Portal, assess requests for support, discuss plans to increase awareness of the Portal and develop a feedback survey. The feedback survey aims to collect evidence from the users about the usefulness of the Portal and any suggestions for improvement. A request for ENAI Ethical Approval for the feedback survey has been issued and is currently pending approval. The Victim Support Portal is active and has supported five cases since its launch in May 2022, with one case made public. The Portal has reached over 550 users from 60 countries, attracting > 6000 page views. The Portal provides several resources (bibliography, guideline documents, stories, blog text, interactive videos).

Plans for 2023: The group will continue actively developing and promoting the Victim Support Portal. Members will also continue to support victims with their reported problems. An abstract will be submitted to the European Conference on Ethics and Integrity in Academia, $12^{th} - 14^{th}$ July 2023, Derby, UK. This abstract will focus on the scoping review study developed to systematically map the topics, issues and gaps in knowledge in the current literature on academic integrity, focusing on studies addressing victims of academic misconduct and institutional support mechanisms available for victims. The group will also



develop an interactive infographic about victims of academic misconduct and an online survey to collect evidence from different target groups (i.e. undergraduate, master and PhD students, early and senior career researchers and academic staff) on knowledge, experiences and support needs on academic integrity and misconduct. A set of recommendations on reporting allegations of academic and research misconduct will also be developed, and members will continue to contribute with resources and other educational materials during 2023.

Testing of Support Tools for Plagiarism Detection

Head: Tomáš Foltýnek, Masaryk University, Czechia

Aims: The Testing of Support Tools for Plagiarism Detection (<u>TeSToP WG</u>) aims to **1)** test the efficacy of different text-matching software, including brand new datasets containing documents from multiple European languages plagiarised from various sources and obfuscated by various methods.

Members: There are currently 13 members of the TeSToP WG, including the head.

Activities: In 2022, the TeSToP working group was not very active. Part of the group finished the TeSToP-J project aiming to test how the systems deal with the Japanese language. Salim Razı and Tolga Özşen from Canakkale Onsekiz Mart University (Türkiye) led this initiative. The results of this work were published in a paper and presented at the European Conference on Academic Integrity and Plagiarism 2022 (ECAIP 2022), 4th – 6th May 2022, Porto, Portugal. At the end of 2022, the publication of ChatGPT raised many questions and concerns related to academic integrity. As a result, the working group decided to change its focus and rename the working group's name to Academic integrity and technology (AIT WG). The new name will be adopted in 2023.


European Conference on Academic Integrity and Plagiarism 2022

The 8th ENAI Annual Conference, European Conference on Academic Integrity and Plagiarism 2022 (ECAIP 2022), with the main theme "Ethics and integrity in the changing world", took place in Porto, Portugal, from 4th to 6th May 2022. Due to COVID-19, the event ran in a hybrid mode (face-to-face and online).



8th International Conference

European Conference on Academic Integrity and Plagiarism 2022 (ECAIP 2022)



The conference was attended by 183 participants (87 in-person and 96 virtually) from over 35 countries worldwide, including Canada, the USA, Australia, Israel, Mexico, Angola, South Africa, India, UAE and several European countries. Delegates of the conference included 70 professors in Higher Education Institutions, 25 researchers (including group leaders), 28 students (the majority being PhD students) and 5 librarians. The remaining participants included directors/managers/officers for academic/research integrity, members of national academic/research integrity networks/offices, journal editors, press members and clinicians.

A total of 81 presentations, including workshops, were delivered during the three days of the conference in 13 thematic sessions. The conference program included presentations from four keynote speakers, Professor Ana Marušić (University of Split, Croatia), Dr Daniele Fanelli (London School of Economics and Political Science, UK), Dr Elisabeth Bik (Independent consultant), Dr Teddi Fishman (Independent Researcher, USA). Participants also enjoyed a one-panel discussion with experts and a guided tour to Porto Old Town and Wine Cellar, where they tasted the famous Porto wine.

The conference program and book of abstract are available on the conference <u>website</u>. All authors of accepted abstracts have the opportunity to publish a full paper in an edited book that will be published in 2023.

ENAI Awards 2022 Winners

To acknowledge the exceptional contributions and courage of those who work in the field of academic integrity, ENAI presented five awards in 2022. Recipients of ENAI Awards have demonstrated continuous commitment to promoting academic integrity and bringing about positive culture change locally, nationally and/or globally. The awards were announced on Wednesday, 4th May 2022, at the ECAIP 2022. The following nominees were confirmed as the winners of the ENAI Awards 2022:

- Sarah Elaine Eaton from the University of Calgary (Canada) received the ENAI Exemplary Research Award for outstanding, nationally and internationally recognised research in the field of academic integrity.
- Dita Henek Dlabolová from ENAI (Czehia) received the ENAI Outstanding Member Award for significant contributions to the advancement of ENAI goals and support to ENAI activities, events and members.
- Lorna Waddington from the University of Leeds (UK) received the ENAI Exemplary Activism Award for her dedication to researching and promoting academic integrity.
- National Agency for Higher Education Quality Assurance (NAQA) in Ukraine received the Tracey Bretag ENAI Memorial Award for their resilience, significant contribution and continuous promotion of a positive approach to academic integrity, even during the threats from the war, being an inspiration and leading by example.
- Megan O'Connor from Trinity College Dublin (Ireland), César González-Lozano from the University
 of Monterrey (Mexico) and Pegi Pavletić from the European Student Union (Belgium) received
 each the ENAI Outstanding Student Award for their dedication to academic integrity research and
 being a positive role model for other students.

ENAI PhD Summer School on Academic Integrity

The ENAI PhD Summer School on Academic Integrity 2022 occurred exclusively on-site between the 22nd and 26th August 2022. It was organised by the Centre for Academic Integrity, Canakkale Onsekiz Mart University, Türkiye, with the collaboration of ENAI members. Ten PhD students from 4 countries (Azerbaijan, United Arab Emirates, Saudi Arabia and Türkiye) participated in the Summer School. The program included a mix of theoretical and practical sessions, where students had the opportunity to engage in discussions with fellow doctoral students about the topics presented by the lecturers. The lecturers were Dr Salim Razı (Canakkale Onsekiz Mart University, Turkey), Dr Sarah Elaine Eaton (University of Calgary, Canada), Dr Shiva Sivasubramaniam (University of Derby, UK), Dr Sonja Bjelobaba (Uppsala University, Sweden), Dr Teddi Fishman (Former Director of the International Center for Academic Integrity, USA) and Dr Zeenath Khan (University of Wollongong in Dubai, UAE | Centre for Academic Integrity in the UAE). The topics included ethical academic writing, research ethics, ethical publishing,



plagiarism and interpretation of similarity reports, digitalisation and the challenges for academic integrity, among others (<u>full program</u>). The lecturers were experts in academic integrity and research ethics from Canada, the UK, United Arab Emirates, the USA, Sweden and Türkiye. Students were also invited to participate in social activities, such as visiting ancient Troy and learning more about this historical place now known as Cannakkale. On the last day, all students were awarded certificates during the certificate ceremony.

ENAI & CRB Monthly Webinars

ENAI, in collaboration with the Centre for Research Ethics & Bioethics (CRB) from Uppsala University (Sweden), organised a series of monthly <u>webinars</u> from September to December 2022. The webinars took place every second Friday of each month at 1 pm CEST/CET and included various topics on academic integrity and research ethics. The webinars were free and open to anyone interested in the topics presented. The lecturers were experts in academic integrity and research ethics. Full program:

- 14th October 2022: <u>Improving skills as a thesis supervisor</u>, by Dr Dita Henek Dlabolová (ENAI Executive Director) and Veronika Krásničan (Erasmus+ <u>BRIDGE</u> Project Output Leader).



- 11th November 2022: <u>Celebrating the European Year of Youth through Academic integrity. How students help in establishing institutional integrity and values</u>, by Oraz Myradov (head of the ENAI Students' Working Group and Executive Committee member of the <u>European Students' Union</u>).
- 9th December 2022: <u>Support for victims of academic misconduct: an interactive portal and support network</u>, by Dr Rita Santos (ENAI Project Manager and Coordinator of the Victim Support Portal).




Figure 3 – Number of registered participants for each ENAI & CRB Monthly Webinar.

Figure 3 shows the number of registered participants for each webinar, from 67 registered participants in September 2022 to 117 registered participants in December 2022.

Erasmus+ Facing Academic Integrity Threats (FAITH)



The Erasmus+ <u>FAITH</u> project started in February 2022 and will be conducted for 36 months (i.e. until February 2025), with an overall budget of 274,709€. The project is coordinated by Canakkale Onsekiz Mart University (Türkiye). It includes four project partners: the University of Konstanz (Germany), the University of Maribor (Slovenia), the University of Porto (Portugal) and the European Network for Academic Integrity (Czechia). The FAITH project aims to:

- a) Establish a benchmark for minimum standards for academic integrity policies in Europe and beyond based on good practice internationally;
- b) Help academics and undergraduate students to prevent, deter and detect academic misconduct through evidence-based guidance and training materials;



c) Support victims of misconduct in research and education through an interactive portal and support network.

Partners of the FAITH project have been collaborating regularly in developing project outputs. The first face-to-face project meeting took place on 3rd May 2022 in Porto (Portugal). This meeting allowed project partners to discuss the reporting periods, administrative issues, project outputs and timeline. During the ENAI European Conference on Academic Integrity and Plagiarism (ECAIP 2022), the project coordinator, Dr Salim Razı (Canakkale Onsekiz Mart University, Türkiye), presented the project's aims and outputs. Dr Rita Santos (ENAI, Portugal) officially launched the Victim Support Portal.






The Victim Support Portal aims to raise awareness and support anyone experiencing an issue of academic or research misconduct by providing a safe space for anyone to expose their situation and receive advice on the potential actions to take from the mentors. The mentors of the Victim Support Portal are experts in academic and research integrity from the FAITH project and extended ENAI network, who dedicate time to support potential victims on their issues.

Since its official launch in May 2022, the Victim Support Portal has supported 6 cases, with 2 cases made public in the Portal after careful anonymisation of the personal details. The Victim Support Portal has attracted over 6,500 page views and 627 users from 50 countries. Project partners have been raising awareness and disseminating the Portal to their networks. Furthermore, partners have developed resources such as a leaflet presented during the World Conference of Research Integrity (29th May – 2nd June 2022), blog texts, webinar, interactive videos, FAQs and an interview. Partners have also enriched the Portal with relevant content such as articles, bibliography on whistleblowers and guidelines to report misconduct in research and education. The Portal was also presented at the QQI 10th Anniversary Conference on 18th October 2022 in Dublin (Ireland), and project partners presented the Portal in their local institutions. All these resources are available here.

Project partners have met several times during 2022 to contribute to the tasks and deliverables of the project and discuss any related issues. Project outputs will continue to be developed and disseminated in



2023, with plans to present the latest achievements during the European Conference on Ethics and Integrity in Academia (ECEIA 2023) that will be held in Derby (UK) from 12th to 14th July 2023.





Plans for 2023

In 2023, ENAI aims to continue supporting institutions in fostering and promoting a culture of academic integrity at their institutional level and beyond through activities and events dedicated to discussing best practices in academic integrity education and emerging issues and promoting the development of resources and materials from the active collaboration of ENAI members in the working groups and research projects. To this end, ENAI aims to expand the current network of members and be actively involved in research grant proposals. Specifically, in 2023 ENAI aims to:

- Expand the current network of ENAI member institutions and individual supporters;
- Build partnerships with European networks (e.g. <u>NERQ</u> Network for Education and Research Quality) and increase international recognition of ENAI;
- Improve the current database of Educational Materials on Academic Integrity;
- Offer regular monthly free webinars on academic integrity and research ethics;
- Organise the European Conference on Ethics and Integrity in Academia 2023 (ECEIA 2023) in cooperation with the University of Derby (UK);
- Elect the new ENAI board during the Annual General Meeting in Derby (UK);
- Organise the 3rd ENAI PhD Summer School on Academic Integrity in cooperation with the University of Maribor (Slovenia);
- Continue and support the activities of the working groups;
- Collaborate actively in ongoing research projects (i.e. Erasmus+ FAITH project);
- Establish research partnerships with active collaboration in grant proposals
- Actively contribute to the Erasmus+ ETHICS (Responsible Conduct of Research Research Integrity and Ethics in Georgian Universities) project, coordinated by Ilia University (Georgia). The project starts in February 2023;



Act as a Stakeholder Advisory Board Member on the recently funded Horizon Europe BEYOND
project that aims to robustly explore and advance individual and institutional responsibilities in
Research Misconduct and in the promotion of RE/RI.

Financial Report

ENAI has used a <u>transparent bank account</u> in <u>EUR</u>, <u>CZK</u> and PayPal since June 2019. All transactions via the bank account are publicly visible.

According to the financial result, ENAI is at a loss.
